**How do I enroll my child(ren)?** If enrolling before April 15, 2011, include a deposit of \$1000 with this application. The balance is due on April 15, 2011. If enrolling after April 15, then include the full payment. For families with more than one child, there is a 5% discount off of the total tuition.

**Withdraws:** Deposits are refundable until March 1, 2011 (less a \$150 processing fee). After March 1, 2011, deposits and payments are non-refundable.

**Camper tuition includes:** airport pickup and drop off at the Portland (Maine) Jetport or Bangor International Airport (for those campers flying to camp), laundry, all in camp activities, and trip days.

**Late fees:** Any unpaid balances for campers registered, but not paid by April 15th will incur a late fee of 1% per month.
